Unfinished Business:

<u>Hurricane Ian Update:</u> Sherry Danko read an e-mail message from Strategic Claims. They expect the window report in late July or early August. The jury is still out on the roof.

Insurance Appraisal: The recent appraisal indicated the insured values on the property and flood coverages needed to be evaluated for increases. Linda Christ moved, and David Bockmann seconded to approve the increases for the property coverages (wind and X-wind) at this time. Discussion followed about the costs involved as well as the upcoming change for the X-wind. Linda Christ rescinded, and David Bockmann withdrew his second on the aforementioned motion. Linda Christ moved, and David Bockmann seconded to increase the insured value on the wind coverage only at this time. The motion carried. David Bockmann moved to increase the insured value for the X-wind policy effective July 29th when the policy was picked up by a new company. After some brief discussion, David Bockmann withdrew his motion. Linda Christ moved, and Kate Hitt seconded to approve the increase in insured value for the new x-wind policy. The motion carried. David Bockmann moved, and Linda Christ seconded to increase the flood insured values with the December 1 renewal. The motion carried.

<u>Summer Meeting Schedule:</u> Linda Christ moved, and David Bockmann seconded to cancel the July and August meetings and only schedule a meeting during this time if needed. The motion carried.
